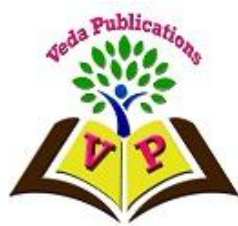

The abstract should summarize the content of the paper. Try to keep the abstract below **150** words. The abstract should mention the scope, hypothesis or rationale for the work and the main findings. The abstract should be written in past tense and presented without subheadings. Do not make references, display equations, figures or tables in the abstract. Your manuscript should be typed/printed on A4 paper (21.0 cm x 29.7 cm) dimension. It is imperative that the margins and style described below be adhered to carefully. This will enable us to keep uniformity in the final copies of the Journal. (11)

**INTRODUCTION (11 BOLD)**

The introduction of the paper should explain the nature of the problem, previous work, purpose, and the contribution of the paper. The contents of each section may be provided to enable easy understanding of the paper. (10)

**HEADINGS (11 BOLD)**

The **headings** and **subheadings**, starting with "INTRODUCTION", appear in upper case letters and should be **set in bold**.The font size for **heading is 11 points bold face** and **subsections with 10 points and bold**. Do not underline any of the headings, or add dashes, colons, etc. (10)

**CITATION (10 BOLD)**

Citations should be **in numbers [1]** and not Authors name and year Ozaki *et al.* (1998)

**PARAGRAPH AND EQUATIONS (10 BOLD)**

The **paragraphs** should be in **INDENTED** style i.e indentation at the beginning of every new

paragraph including the first paragraph after a heading. A colon is inserted before an equation is presented, but there is no punctuation following the equation. All equations are numbered and referred to in the text solely by a number enclosed in a round bracket (i.e., (3) reads as "equation 3"). Ensure that any miscellaneous numbering system you use in your paper cannot be confused with a **reference [4]** or an equation (3) designation. (10)

**FIGURES AND TABLES (11 BOLD)**

To ensure a high-quality product, diagrams and lettering **MUST** be either computer-drafted or drawn using India ink. Figure captions appear below the figure, are centralized, and are in sentence case letters "Figure". Figures should be numbered in the order they appear in the text. Table captions appear centered above the table in upper and lower case letters. When referring to a



table in the text, no abbreviation is used and "Table" is capitalized. (10)

### **CONCLUSION (11 Bold)**

A conclusion section must be included and should indicate clearly the advantages, limitations, and possible applications of the paper. Although a conclusion may review the main points of the paper, do not replicate the abstract as the conclusion. A conclusion might elaborate on the importance of the work or suggest applications and extinctions. (10)

### **ACKNOWLEDGEMENTS (11 Bold)**

An acknowledgement section may be presented after the conclusion, if desired. (10)

### **REFERENCES (11 Bold)**

A reference list **MUST** be included using the following information as a guide. Only *cited* text references are included. Each reference is referred to in the text by a number enclosed in a square bracket (i.e., [3]). References **must be numbered and ordered according to where they are first mentioned in the paper**, NOT alphabetically.

*Note that the title of the book is in lower case letters and italicized. There is no comma following the title. Place of publication and publisher are given.*

#### **Chapters in Books:**

[1] Bishop PO, Neurophysiology of binocular vision, in J.Houseman (Ed.2), *Handbook of physiology*, 4 (New York: Springer-Verlag, 1970) pp342-366. (8)

*Note that the place of publication, publisher, and year of publication are enclosed in brackets. Editor of book is listed before book title.*

*Note that thesis title is set in italics and the university that granted the degree is listed along with location information*
